**NOTICE FOR INVITING EXPRESSION OF INTEREST (EOI) FROM EXPERIENCED E-PORTAL/E-MARKETPLACE FOR EMPANELMENT WITH TILAM SANGH FOR PROCUREMENT AND DISPOSAL OF EDIBLE OILS, AGRI COMMODITIES, CERTIFIED SEED ETC.**

**INTRODUCTION**

Tilam Sangh was registered on 19.09.1957 under Rajasthan Co-operative Societies Act, 1964 and is acting as an apex organization in the cooperative sector to cater to the needs of the farming community through network of member cooperative societies.

Tilam Sangh undertakes purchases of agricultural commodities under Minimum Support Price (MSP) and Market Intervention Schemes (MIS) on appointment by Govt. of India &/or Govt. of Rajasthan as a procuring agency/agent.

Tilam Sangh invites application to empanel service provider for procurement and/or disposal of edible oils, agri commodities, certified seed etc. through an online e-marketplace. Tilam Sangh is to engage such e-marketplace to facilitate bidding process through online platform. The empanelled e-marketplace will be required to register manufacturer/trader/buyer/seller on their platform and to conduct auction/reverse auction on the portal to ensure participation in the bidding process. The bidding process shall be based on auction or reverse auction or any other policy based on the nature of contract decided from time to time by Tilam Sangh.

Intending e-portal service provider shall submit application in the prescribed Application Form (dully filled) along with supporting documents to the Managing Director, Tilam Sangh, 2<sup>nd</sup> Floor, Nehru Sahkar Bhawan, Bhawani Singh Road, Jaipur – 302 001 (Rajasthan).

**A. Eligible criteria for empanelment**

1. The intending application shall be a Company registered under the relevant provisions of Companies Act of 1956 or 2013, The intending applicant shall submit Certificate of Incorporation, Memorandum & Articles of Association and a Board Resolution in favour of authorized signatory, duly certified by a competent authority. The 100% subsidiary of the parent company may be considered subject to submission of relevant documents duly certified by competent authority.
2. The applicant must have its own e-portal for managing e-auctions/reverse auction for procurement & disposal of edible oils, agricultural commodities, certified seed etc. in India.

3. The applicant must have experience of offering e-portal services to minimum three Central/State Government Organizations for procurement or disposal of edible oils, agri commodities, certified seed etc. through its e-portal.
4. The applicant must have, on its payroll (as on date of issue of notice), minimum technical full time manpower as specified in table below. The applicant shall attach resumes of the manpower supporting documents.

5. The applicant must have PAN, GST Registration No. in its name and shall provide copies of the same.

1. The successful applicant shall be responsible for hosting, managing and upgrading of the e-auction portal.
2. During the operation period, the applicant shall ensure adherence to minimum Service Level Agreement (SLA) as agreed mutually between and the Authority at the time of development.

**Tenure of the Agreement:** Approved service provider would be eligible to provide e-portal services for a period of One Year from the date of execution of the agreement as per the terms & conditions decided by Tilam Sangh.
