3. HDPE used for making Jars should be Food Grade, Odour free HDPE virgin material conforming to IS 10149 : 1982.
4. HDPE Jar must confirm to BIS specification no. IS 15473 for blow moulded HDPE containers for packing of edible oil.
5. **Colour and Code :** The HDPE Jar and cap should confirm to the colour specified and should use Master Batches of Food Grade reputed make confirming to IS 9833 : 1981 to be use as mentioned below as per PANTONE SHADE CARD CODE also

g. Jar weight with tolerance in gms	: 210+/-3
h. Cap weight in gms.	: 5
i. Total weight of Jar including outer Cap in gms.	: 216+/-5
j. Jar Capacity in ml.Brimful	: 5350
7. The Jars should not burst in the drop test
8. The Jars should be leakproof and suitable for hot sealing wherever required.
9. The Jars should be free from dust, insects & any other impurities objectionable in edible oil packing.
10. The colour of the Jar should be uniform and as per the colour specified and finalized by the Federation.
11. The shape of Jar and Cap and side handle should be as per the design, colour and specification mentioned.
12. On all the Bills, it is to be certified by the manufacturer that the material used for HDPE Jar is Food Grade and Jars are conforming to the BIS specification no. IS – 15473
13. The WAD should be printed with Tilam Logo and should be made from Food Grade material acceptable by concerned authority.
14. All testing parameters should be as per ASTM /Indian standards etc. COA including drop test and top load test with 40 to 50 kg. weight with Food Grade certificate issued by granule manufacture also.
